PM-WANI Central Registry

Mandate Given to C-DOT – Development of Central Registry

Central Registry has following features:

- PDOA Portal for onboarding of PDOA's
- APP Provider Portal for onboarding of APP Providers.
- Admin Portal to view the PDO, APP Providers and their status's as well as provision to certify them.
- Integration with Saral Sanchar portal of DOT for ease of registration of prospective PDOAs and APP Providers.
- Test setup to facilitate certification of PDOA stack and APP.
- Main page section to provide the information about PM-WANI scheme.

Additional Feature Development in Central Registry

- Original WANI framework proposed by TRAI in 2017 was based on MAC ID. However due to MAC randomization, it is not possible to identify the end device through a single MAC Id.
- Hence **PM-WANI 2.0 Architecture** was released by C-DOT to take care of MAC randomization issue.
- Design and Development of Certification modules and setting-up of certification lab.
- Integration of CR with portals like Darpan/Prayas portal of Prime minister's schemes for the decimation of information.
- PDO Portal developed in CR to provide an interface to connect prospective PDOs with PDOAs. The details of PDO is sent to all the PDOAs.
- MIS Report generation module developed to generate various types of reports.

Additional Feature Development in Central Registry

- PDOA and APP Provider KPI (Key performance Indicator) API details provided to all PDOAs for implementation. KPI information of PDOAs are available at the CR.
- Map on the Website showing the location of PM-WANI hotspots to display WANI sites on Google map.
- Development of Multi-lingual CR. Completed in all major Indian languages (17).
- Central Registry portal migrated to NIC cloud with new URL (www.pmwani.gov.in).
- Booklet for PDO, PDOA and APP Provider prepared in all major Indian Languages (17).
- **Submitted consultation paper to DOT for the roaming feature in PM-WANI.**

Initiative to Develop PM-WANI Ecosystem

Challenges in PM-WANI Proliferation

- Urban Centric deployment
- High cost for backhaul
- Integrated offering by major players (PDO, PDOA and APP by single entity)
- Non-availability of plug-n-play WANI Access Point.
- Limited PM-WANI Software Solution provider

Initiative Taken by C-DOT to enable PDOAs and APP Provider



- White-label PDOA stack and PM-WANI APP for prospective PDOA and App Providers.
- Provision of C-DOT cloud to host PDOA and APP solution.
- Development of Indoor and outdoor PM-WANI Access Points (Wi-Fi 5 & 6) for fast proliferation of PM-WANI by PDOAs.
- Migration of **BSNL and Railtel** Wi-Fi network to PM-WANI using C-DOT WANI token handler.

Business Support System for PDOA & PDO

- Subscriber Management Module:** Complete management portal for the subscriber/user by PDOA
- PDO/Hotspot Management Module:** Every PDO can create the plan and see the utilization of respective PDO.
- Voucher Management Module:** PDOA can generate voucher as per the business condition including the wallet feature.
- Revenue Settlement Module:** Automatic revenue settlement between PDOA and PDO as per the agreed terms and condition between PDOA and PDO
- Device Management Module:** Complete device (AP) management, configuration, remote release upgradation and alarm monitoring feature.
- Helpdesk Module:** Helpdesk module for the support to user and PDO by the PDOA as well as helpdesk to support PDOA by C-DOT.

Certification of Framework

PM-WANI Framework: Compliance Requirement

Interoperable Operation

- The PDO, PDOA and APP Provider need to be compliant to the framework for Inter-operable working
- The WANI Token handler module (responsible for the message communication between PDOA and APP) is the key component of the framework.
- Access point has to be integrated with the PDOA software. Any available Access point cannot seamlessly work with the PDOA software without the support of OEM.

PM-WANI Framework: Compliance Requirement

Certification Requirement

- Certification of PDOA and APP is mandatory to meet the compliance of the framework.
- Provisional certified PDOA/APP Provider need to be formally certified for interoperable operation as per the Test Schedule and Test Procedure (TSTP).

Mandatory LI Compliance

- In the PM-WANI framework Access Point require storage facility to capture/store the NAT log for Lawful Interception (LI) related compliance.
- For the proper log, NTP support is mandatory in the Access Point for proper time-stamp.

- C-DOT's indigenously designed Wireless Terminals are ideally suited to diverse deployment scenarios
- Ruggedized Terminals capable of working in extreme operational environment
- Installed nationwide with active participation of local entrepreneurs and start-ups
