- KYC unbundled from Shopkeeper (PDO)
- No License & No License Fee
- Seamless Sale of Data by Shopkeeper (PDO)
- Interoperable & Seamless Connectivity
- Multiple Location Access on same wallet
- Ease of setting up of Hotspot (Plug & Play Model)
- One time OTP based Authentication
- Flexibility in Tariffs
- Defined Roles (PDOAs, App Providers, PDOs, Central Registry)

# Fixed BB & Public WiFi Critical part of Connect India Policy Objectives

NDCP 2018 -

- Broadband for ALL
- Enable fixed line broadband access to 50% of households
- Enable deployment of public Wi-Fi Hotspots; to reach 5 million by 2020 and 10 million by 2022
- Provide 1 Gbps connectivity to all Gram Panchayats of India by 2020 and 10 Gbps by 2022
- Implementation to be funded through USOF and Public Private Partnerships:
- NagarNet Establishing 1 Million public Wi-Fi Hotspots in urban areas
- JanWiFi Establishing 2 Million Wi-Fi Hotspots in rural areas
- National Broadband Mission Dec 2019
- All villages to have access to broadband by 2022

Public WiFi Implementation falling short by 98%
